Certified For Use in California Elections**

As the elected County Clerk-Recorder/Registrar of Voters, with 20 years of election experience, I take pride in my office for conducting fair, accurate, secure and accountable elections. In those 20 years, my office has instituted four changes in voting systems from Votomatic, Datavote, Mark-A-Vote to AccuVote TSx. Each change was done to improve the voting process. Our number one concern was the accuracy of the vote count. I can unequivocally state that more votes are counted accurately on the touch screens than on the paper-based systems.

In a short timeframe and despite regulatory disruption, Butte County successfully implemented a new voting system in 2006 and met the sweeping changes and rigorous standards mandated by the "Help America Vote Act of 2002" (HAVA). Butte County is proud of its success in implementing an electronic countywide DRE system which met with overwhelming voter approval. Conditions were implemented for use of the system as established by the State, such as, "chain of custody" and "tamper evident seals." This office is dedicated to ensuring that all Butte County eligible voters will have equal access to voting.

The staff and I know that voter and poll worker confidence in the integrity of our voting system was vital to our success. By working cooperatively, the Secretary of State and county registrars can ensure continued success and transparency of the elections process in California as we prepare for three major statewide elections in 2008. The integrity of all voting systems is fundamental to public confidence in elections.

I believe the approach the State should take is to review all systems currently certified, to set standards for training, logic/accuracy testing, and security that are consistent. **The review should set valid standards for improvements to the systems, rather than cause decertification of systems.**



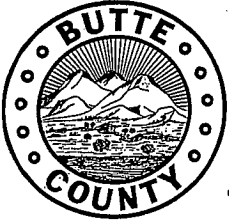


